Dear Sirs:

We, members of the InterReligious Task Force, are extremely concerned about the continued construction of Glamis Gold's Marlin mine in the Department of San Marcos, Guatemala. On January 11, **Raul Castro Bocel and Miguel Tzorin Tuy**, two indigenous farmers involved in the protest of the transportation of machinery to the mine, were killed by Guatemalan authorities. This mine, funded by the World Bank, has been started without legitimate consultation with indigenous populations and environmental organizations and without hearing local and national opposition that has been expressed through many means for over a year. We demand that **Mr. Wolfensohn do the following:**

- Cancel further disbursement of the International Finance Corporation's (IFC) \$45 million loan for the Marlin project;
- Initiate an independent and thorough review of the project from Glamis Gold's first applications for exploration licenses to date. This study must examine legal, cultural, environmental and spiritual aspects and impacts of the project. It must bring to light the procedures followed by the Guatemalan government and by the IFC in their reviews of the project's environmental impact assessment and loan application. It must evaluate these procedures according to the IFC's environmental and social policies and Guatemalan law, including the International Labor Organizing (ILO) Convention No. 169.

We urge Mr. LaRue to call on President Berger of Guatemala to

- Open an investigation into the murders of Raul Castro Bocel and Migeul Tzorin Tuy, make the results public, and bring those responsible to justice;
- suspend the license for the Marlin project;
- place a moratorium on all mining permits on indigenous lands until the results of the independent review described above have been reported and its recommendations implemented.

Thank you for your prompt attention to these urgent concerns for environmental protection and the rights of indigenous peoples.
