Dear Sirs:

We continue to be deeply concerned about the ongoing intimidation and violence toward the peasant organization of Nueva Linda Finca (farm) in Champerico, Retalhuleu Department. On April 27 Selvin Agusto Pérez Galicia, a member of the landowner's private security forces, fired an M-16 toward 25 members of the Movimiento Campesino en Resistencia Pro Justicia Finca (CCICSO), who are camped near the highway outside the finca. He also made a death threat against **Mariano Calel Aguilar**, president of the board of the Movimiento Campesino.

Members of the Movimiento gave testimony to the police, who promised to report the incident to the Public Prosecutor's Office. Pérez Galicia has not yet been arrested.

This most recent incident is only one in a series of acts of intimidation and aggression against campesinos at Nueva Linda:

August 31, 2004...National Civil Police forcibly evicted campesinos (peasant farmers), killing 12 and injuring 45 November 21, 2004...private security guards evicted more campesinos who had reoccupied the finca September 5, 2003...campesino leader Hector Reyes was disappeared

January 20, 2006...three members of the private security forces, including Selvin Agusto Pérez Galicia, shot at them the campesino encampment, injuring Roberto Miguel González, Macario Gómez, and Bernabé Guillén.

We have sent at least three previous letters to Guatemalan officials, demanding that you investigate the violence against the campesinos at Nueva Linda and the abduction of Hector Reyes and bring those responsible to justice (December 3, 2004, February 23, 2005, January 24, 2006). Hector Reyes remains disappeared. To date the state institutions have failed to investigate or act to end the violence.

Again, we strongly urge that you

- conduct a thorough, impartial investigation of the Nueva Linda case, including the disappearance of Héctor Reyes and all subsequent incidents.
- issue an arrest warrant for Selvin Agusto Pérez Galicia in connection with the incidents of January 20 and April 27 of this year.
