Dear Sirs:

We are outraged at the brutal assassination of union organizer **Santiago Rafael Cruz** on April 8 in the office of the Farm Labor Organizing Committee (**FLOC** - Foro Laboral del Obrero Campesino) in Monterrey, Nuevo León state. His hands and feet had been tied and he had been severely beaten on his head and face. Nothing had been stolen from the office.

We believe that this murder was a targeted political attack on the union for its work in protecting the human rights of Mexican migrants going to the US as seasonal farm workers. The assassination of Santiago Rafael Cruz came after more than two years of media attacks, deportation threats, robberies, and violent intimidation of the FLOC office and its staff. FLOC opened the office after winning a collective agreement to represent nearly 7,000 H2A "guest worker" farm workers traveling to the U.S. The FLOC agreement and a court case have helped eliminate bribes, extortion, and other corruption in the recruitment of these workers in Mexico, jeopardizing the lucrative interests of field recruiters.

We are also extremely concerned for the safety of **FLOC director Cástulo Benavides Rodríguez** and other staff members in Monterrey.

The Inter-American Commission on Human Rights (IACHR) has granted FLOC's preventive measures petition. This instructs the Mexican government to "adopt the necessary measures to guarantee the life and physical security" of FLOC staff in Mexico and to keep the IACHR informed of the judicial process to bring Santiago's killers to justice. Beginning April 23, they have seven (7) days to implement these instructions.

We therefore **strongly urge** that you:

- conduct a full, prompt and impartial investigation into the murder of Santiago Rafael Cruz, make the results
 public and bring those responsible to justice
- act promptly for the complete implementation of the directives of IACHR to ensure the protection of the FLOC staff and office in Monterrey.
