Dear Sirs:

The latest abuse (in the long and sordid history of abuses) in Chiapas occurred on July 17 in San Christobal de las Casas, Chiapas.

**Manuel Gómez Hernández**, a Tsotsil indigenous worker with the Fray Bartolomeo de las Casas Human Rights Center, received a telephone call at his home at 9pm. The caller identified himself as "German" and said he was a judge in Zincantan municipality. Manuel Gómez was told to stay out of a case he's working on in Zinacantan or "you will suffer the consequences…we can find you anytime." In the past he has been intimidated and attacked as a result of human rights work.

In at least four previous letters we have protested abusive actions against Tsotsil people and other cases being defended by the Human Rights Center in Chiapas:

<u>Sep 1, 2004</u> – two lawyers falsely charged and illegally detained; their three clients beaten and tortured to obtain confessions

Aug 31, 2005 – another prisoner tortured in an informal detention facility

<u>Dec 12 2005</u> – two members of Civic Action–Chiapas who were exposing official corruption in Hurricane Stan relief aid were severely cut, kicked and beaten by six men. Also detained and harshly interrogated was the director of the newspaper El Orbe, which reported official corruption.

Mar 12 2006 – a journalist with the newspaper Cuarto Poder who exposed corruption by the state Schools Construction Committee was accused of defamation and released on bail; he is now being threatened with a fine of \$20,000.

The authorities must not do less than

- 1. call for a prompt, impartial investigation into the July 17 threat, make the results public and bring those those responsible to justice;
- 2. ensure that Manuel Gómez does not suffer any further intimidation and that he will be protected, in accordance with his wishes:
- 3. recognize the legitimacy of the activities of human rights defenders and their right to conduct their activities without restrictions of fear of reprisals, as outlined by the United Nations.
