Dear Sirs,

The disclosures of mass graves of indigenous people by Guatemala Forensic Anthropology Foundation (FAFG) is apparently viewed as threatening to the impunity of those who created the graves.

Fredy Peccerelli, the executive director of FAFG and his family have received death threats.

**Jeannette Peccerelli**, his wife, had a gun put to her head and was told that her husband was being watched. **Omar Giron Bertoni**, worker at FAFG and brother-in-law of Fredy Peccerelli, his wife and other FAFG workers have been told that they will be punished for the work they are doing. Since the first forensic team was formed in 1992, death threats have been constant.

On September 8, 2005, **Mario René Pacheco**, representative on the Civil Society Assembly in Escuintla, was murdered near Nueva Concepción. He had fought for justice and the development of dignity and cultural revitalization of his community. On the same day campesino leader **Paulino López** was murdered in El Paraíso in Jalapa.

There must be an end to the impunity with which powerful sectors continue to act in Guatemala. To that end, it is imperative that the authorities

- investigate the murders of Paulino Lopez and Mario René Pacheco, make the results public, and bring those responsible to justice;
- ensure the safety of **Fredy Peccerelli**, his family and all other members of FAFG;
- investigate the threats received by Jeannette Peccerelli and Oman Giron Bertonio, make the results public, and bring those responsible to justice.

Be reminded that failing to protect human rights workers and investigate attacks or threats against them is violation of the Peace Accords, under which the government agreed to "investigate, in a timely and exhaustive manner any complaint it may receive relating to acts or threats that may be directed at them".
