Dear Sirs:

We, members of the InterReligious Task Force, are extremely concerned for the safety of Nineth Montenegro, Chair of the Congressional Commission on Human Rights. Montenegro received a death threat, which appears to be linked to her work investigating corruption among high-ranking military officers. She has been investigating government spending from 2000 to 2004, and has discovered that over a billion quetzales (US\$133 million) has been embezzled from the budgets of the Ministry of Defense and two other military institutions.

On August 23, Montegegro filed a complaint with the Public Ministry, which prosecutes criminal cases, accusing senior military officers of embezzlement and corruption, including Colonel Raul Cerna, the former Financial Head of the Estado Mayor Presidencial (EMP). On November 22, a man approached a member of the human rights organization where Nineth Montenegro's husband works, and told him, "something big will happen to Nineth or her family before the end of the year." Colonel Raul Cerna had not been seen since April 2004 until his body was found recently; it is feared that he was killed to prevent him from implicating others.

## We strongly urge you to:

- begin a prompt, impartial and exhaustive investigation into the death threat received by Nineth Montenegro on November 22, make the results public and bring those responsible to justice;
- carry out a full, prompt and impartial investigation into the killing of Colonel Raul Cerna, publish the results and bring those responsible to justice;
- please work to establish CICIACS (the Commission for the Investigation of Illegal Bodies and Clandestine Security Apparatus), in order to prosecute illegal groups operating in Guatemala.
