Dear Sirs:

We are extremely concerned that on January 20, private security guards opened fire on protesters at the Nueva Linda finca in Champerico, Retalhuleu Department. At least three campesinos, **Roberto Gonzáles**, **Macario Gómez and Bernardo Guillén** were wounded.

Campesino leader Aparicio Pérez said that the protesters had conducted themselves peacefully at the entrance to the finca, "w aiting only for justice." This incident is related to the violent eviction of w orkers from the finca in August 2004 (resulting in nine campesino and three police deaths) and the disappearance of finca administrator and campesino leader Hector Reyes (on September 5, 2003). Although there w as sufficient evidence at that time against tw o of the finca's private security guards suspected of abducting and murdering Reyes, arrest w arrants were never carried out.

According to the Nueva Linda Justice Group, on January 20 campesinos were "heading tow ard the finca peacefully, with nothing more than their calls for justice" about Reyes' disappearance and demanding that he be released alive. Security guards opened fire. The police arrived but refused to arrest them. Furthermore, there w as no presence of the Human Rights Ombudsman (Pocuradoría de Derechos Humanos, or PDH).

We have written Guatemalan officials on previous occasions about the violence at Nueva Linda (December 3, 2004 and February 23, 2005). We are disappointed that authorities have not put a stop to this conflict.

We urge that you

- conduct a full, immediate, and impartial investigation into the violence at Nueva Linda finca on January 20 and apply justice fully and impartially;
- prosecute those responsible for the forced disappearance of Hector Reyes;
- pursue justice in the killings that occurred during the Nueva Linda eviction in 2004, at least three of which were classified by the Human Rights Procurator as extrajudicial executions.

Thank you for your prompt attention to these concerns.
