Dear Sirs:

We are deeply concerned about the murder of four campesinos **Arelis Diaz, Alcibiades Pachon, Luis Guillermo** and **Rafael Quinto** by Plains Self-Defense paramilitaries in Mata Bambu, Puerto Lleras municipality, Meta Department, on January 5. We are equally disturbed by the paramilitaries' disappearance of four siblings, **Yurley** (age 17), **Esteban** (age 13), **Rafael** and **Amir Rodríguez,** also from Mata Bambu. Several others were wounded. Among the paramilitaries were two men recognized as active duty soldiers from the Counter-Guerrilla Battalion No. 42 of the Army's 4th Brigade.

The massacre culminated two weeks of attacks and disappearances of area residents by military and paramilitary forces. Disappeared were **Norberto Lujan** (E Vergel, Vistahermosa municipality), **Ecelino Piñeda Peña** (Santa Lucia), **Gildardo de Jesus Salinas Piedrahita** (Villa La Paz, Puerto Lleras municipality) and **Rosabel Rincon** (Santo Domingo); all remain missing as of January 18. On January 3, soldiers detained eight campesinos in Santo Domingo; as of January 18, seven are still missing.

Soldiers told members of the Human Rights Commission of the Güejar River Region in Puerto Toledo that the same thing that happened in Mata Bambu would soon happen to them. When Commission members visited Lt. García, head of Brigade No. 4, García said he was not committed to providing security for civilians in Puerto Toledo. Lt. García then blocked residents of Puerto Toledo from fleeing the tow n.

As a result of our deep concern for the safety of the civilian population of Meta Department, we strongly urge you to:

- Immediately conduct a full and impartial investigation into the killings in Mata Bambu and the numerous disappearances betw een December and January 2006, make the results public, and bring those responsible to justice;
- Reveal what steps you are taking to protect the civilian population in the area;
- Conduct a full, impartial investigation into links between the security forces and paramilitary groups in Meta;
- ▶ Immediately act to dismantle paramilitary groups, in line with stated government commitments and recommendations made by the United Nations and other intergovernmental organizations.
