Dear Sirs:

We, members of the InterReligious Task Force, are extremely concerned about the death of **Felipe Alvarez**, a member of the Consejo Comunitario de Desarrollo (Community Council for Development, COCODES), a community development organization based in the community of Microparcelamiento El Naranjo, Esquintla Department. Early on the morning of December 8, he left his home to cycle to the farm where he worked. His body, shot once in the head and three times in the back, was found by police officers at 5:45am the same day on a roadside about 10 km south of his home on the way to the farm. He had claimed that he had been followed on several occasions.

COCODES are local community structures that support the work of the municipal authorities. They were created by law in 2002 under provisions laid down in the 1996 Peace Accords to strengthen community democracy and participation. In the past two years two other members of the organization have been killed and its members threatened, apparently because of the organization's attempts to improve public security in their community. We believe the two remaining members of the organization, **Juan Francisco Almira** and **Manuel Antonio Aguita**, are at grave risk.

We remind you that human rights defenders, including community leaders, have the right to carry out their activities without any restrictions or fear of reprisals, as set out in the UN Declaration on the Rights and Responsibilities of Individuals, Groups and Institutions to Promote and Protect Universally Recognized Human Rights and Fundamental Freedoms.

We strongly urge that you:

- order immediate and effective measures to guarantee that Juan Francisco Almira and Manuel Antonio Aguita are safe from future threats, acts of intimidation and attacks.
- carry out a swift and impartial investigation into the killing of Felipe Alvarez and bring those responsible to justice.
