## Dear Sirs:

We write to you with great concern for flower workers in Colombia. As the sole distributor of flowers grown at Exportaciones Bochica S.A. CI Flower Company (Bochica Farms), Spectrum has a responsibility to defend the rights of its workers and to ensure full compliance with Colombian labor law and International Labor Organization (ILO) conventions.

On January 28, 2007, workers formed the Unión de Trabajadores de Exportaciones Bochica S.A. CI and filed for legal recognition the next day. They soon began receiving death threats. To date, Exportaciones Bochica refuses to negotiate with the union, and Spectrum Flowers has not responded to requests for intervention.

Hugo Cifuentes, the manager of Exportaciones Bochica, held a meeting with workers and made it clear that he did not want a union. Shortly thereafter, he approached several union members and pressured them to disaffiliate. At another meeting, Cifuentes warned workers of the dangers of forming a union in Colombia; individuals in military uniform were present. Two days after this meeting, the union president, treasurer, and auditor received written death threats from the paramilitary group Aguilas Negras del Oriente.

In April 2007 the workers reported that they never received protection from the government's well-publicized Trade Union Protection Program, because (as the government claims) the union's registration was denied, meaning that they are not technically members of a union. Because of the combined company/paramilitary strategy at Bochica Farms, only seven union workers remain. They are now affiliated with The National Union of Agro-industry Workers (SINTRAINAGRO) who demanded negotiations in October 2007. The company has not complied. They are legally required to negotiate but the government of Colombia is not enforcing this rule.

As a result of these hostile activities, and in view of Colombia's questionable history of dealing with union members and leaders, we strongly urge you to:

- > actively protect these workers from threats and intimidation, by either managers at the company or by paramilitaries and other armed groups;
- > conduct an independent investigation into any and all allegations of threats or intimidation;
- take any action necessary to help negotiate in good faith with the workers and to ensure a safe working environment in which all labor rights can be freely exercised and respected;
- respect and defend the rights of all workers to form and participate in a union freely and without fear of reprisal, as defined by both Colombian and international law.
