Dear Sirs:

We are extremely concerned for the safety of members of the following groups, who have been threatened with death by the army-backed paramilitary group "Black Eagles" (Aguilas Negras):

- Magdelena Medio Peace and Development Program (Programa de Desarrollo y Paz del Magdalena Medio)
- Human rights organization, Corporación SEMBRAR
- > Agro-Mining Federation of Southern Bolivar Department, FEDEAGROMISBOL (La Federacion Agrominera del Sur de Bolívar)
- > Catholic priests working in the municipalities of Tiquisio, Arenal and Regidor in Boliva Department

During FEDEAGROMISBOL's regional assembly in Tiquisio, March 26-30, police and military hassled participants as they tried to identify movement leaders. The military has already assassinated several members of the FEDEAGROMISBOL and community leaders in the Southern Bolivar region; then the military claims that the victims were guerrilla fighters killed in combat. For example, members of the Army's Batallion Nueva Granada killed FEDEAGROMISBOL leader Alejandro Uribe on September 19, 2006, and then presented him as a guerrilla.

On April 10, members of the groups mentioned above received an e-mail death threat signed by the Black Eagles (Aguilas Negras): "...your names are on the national government's list of undesirables who must be eliminated."

Because of our great concern for the safety of members of FEDEAGROMISBOL, SEMBRAR, the "Programa de Desarrollo y Paz del Magdalena Medio" and Catholic priests working in the municipalities of Tiquisio, Arenal and Regidor in Bolivar Department, we strongly urge you to:

- ensure that all measures deemed appropriate by the individuals and organizations named in the threat received on April 10 are taken to guarantee their safety;
- order full and impartial investigations into the death threat received on April 10, publish the results and bring all those responsible to justice;
- take decisive action, in line with repeated UN recommendations, to confront and dismantle paramilitary groups operating in the region and investigate and break their links with the security forces;
