Dear Sirs:

We are writing to express our deep concern regarding the use of lethal force and ill-treatment of migrants in Mexico. On September 18, seven migrants who were traveling without the required documents were being transported in a pickup truck by two people smugglers near the town of Comitan, Chiapas state. When the driver failed to stop at a security check point, security forces gave pursuit and opened fire on the truck, hitting it repeatedly. One of the migrants, Victor Alexander Melgar Lemus, a Salvadoran national, was killed. The other five migrants and one of the smugglers received gunshot wounds. Three who were seriously wounded and unable to flee were interrogated; military and police officers kicked them and hit them with gun butts.

Two migrants are currently receiving treatment in a hospital and are being guarded by National Migration Institute officials; a third one is in detention and in the process of being deported to his country of origin. The National Human Rights Commission opened an investigation into the incident. Knowing that there have been numerous instances of human rights violations against irregular migrants in Mexico (see our letter of Feb 1, 2009), we are very concerned that these extremely vulnerable migrants may be intimidated or threatened by the security forces responsible in order to deter them from pursuing a complaint.

Therefore, we strongly urge that you

- · open an investigation into the use of excessive force and the ill-treatment of the irregular migrants that led to the death of Victor Alexander Melgar Lemus and the wounding of six other persons:
- ensure that the safety of all the migrants who witnessed the events are guaranteed;
- provide these witnesses temporary visas so they can assist in the investigation into the incident and abuses without fear of reprisals or repatriation.
