Dear Sirs:

We are extremely concerned about the safety of journalists in Honduras, particularly in light of the recent assassination of **Israel Zelaya Díaz**, a radio reporter for *Radio Internacional*, who was found shot to death August 24 along a rural road near San Pedro Sula, Cortés Department. According to reports, he was last seen alive on August 24 around 2 p.m. as he was talking with a man in a taxi at a gas station.

Although Israel Zelaya Díaz had not mentioned receiving recent threats, his home was damaged in a fire of undetermined origin three months ago. Zelaya reported on a wide range of local topics, including politics and crime, but he was not involved in investigative work.

The Committee to Protect Journalists (CPJ) reports that eight journalists have been killed since March (cf our letters of Jan 25, Mar 3, Apr 26 and May 11, 2010). Government officials have tried to minimize these crimes and play down the pervasive climate of impunity in the country, but CPJ research shows a pattern of botched and negligent investigative work into the killings.

We strongly urge you to:

- conduct a swift, independent, thorough and impartial investigation into the murder of Israel Zelaya Díaz, make the results public, and bring those responsible to justice;
- adhere strictly to the UN Declaration of Human Rights, which ensures journalists the right to carry out their activities without any unfair restrictions or fear of reprisals;
- ensure the safety of all people exercising their right to association and free expression.
