Dear Sirs:

We are deeply concerned for the safety of Mexican trade unionist and Oaxacan political activist **Marcelino Coache and his family.** On January 31 Marcelino Coache's son, Edgar Coache Verano, received a death threat saying, "he's going to die..." We believe this threat referred to Marcelino Coache.

This is the latest in a series of acts of intimidation against Marcelino Coache. On March 4, 2009, he was abducted, beaten and tortured for several hours by three men in Oaxaca City. During the same month, as his son was walking home from school, he was followed by several unidentified men in a van who shouted insults and threats at him. In April and August 2009, Marcelino Coache's wife, Reyna Rivera, received several threatening messages on her mobile phone as did other Oaxacan human rights defenders who have been supporting Marcelino Coache. We have called your attention to each of these abuses in previous communications (cf letters of 4/3/2009, 5/13/2009, 8/26/2009).

We are convinced that these threats and acts of intimidation are related to the fact that Marcelino Coache is a leading member of the Popular Assembly of the People of Oaxaca (APPO), which has been campaigning to bring to justice those responsible for human rights violations during Oaxaca's 2006 political crisis.

On May 8, 2009, the Inter-American Commission on Human Rights asked the Mexican government to provide protection for Marcelino Coache. To date, the Mexican government has failed to provide him with effective protection. Furthermore, those responsible for the threats and intimidation remain at large. This represents an egregious violation of Marcelino Coache's rights as a citizen of Mexico!

## In view of the information cited above, we strongly urge that you

- ensure that Marcelino Coache and his family are given appropriate protection in accordance with their wishes;
- order a prompt and impartial investigation into the attacks and threats suffered by Marcelino Coache and his family and bring those responsible to justice.
