Dear Sirs:

We are very disturbed by the continuing repression and criminalization of peaceful protests taking place in Honduras, the latest of which has resulted in the death of **Ilse Ivania Velásquez Rodríguez**, a teacher and founding member of the Committee of Relatives of the Detained and Disappeared in Honduras (COFADEH). On March 18 she was hit in the head with a projectile tear gas canister fired by police and then struck by a police tank.

Teachers are protesting the new General Education Law, which they believe to be a legal mechanism to move towards the privatization of all levels of education. On March 17, in the cities of Tegucigalpa, Comayagua, and Danlí, the preventive police and men in civilian clothing, driving cars without license plates, repressed peaceful demonstrations of teachers and members of the National Front of Popular Resistence (FNRP). According to reports, as many as 50 people were detained, wounded, and beaten.

On March 28, human rights defender **Miriam Miranda Chamorro** was detained for ten and a half hours by authorities in the municipality of Tela, Atlántida Department. She is the President of the Organización Fraternal Negra Hondureña (OFRANEH) which has worked since 1978 to promote political, social, and economic rights of the Afro-Carribean Garífuna community. She was the only person detained from a large group peacefully protesting in solidarity with the striking teachers. During her arrest, a number of tear-gas canisters were reportedly fired directly at her, causing her serious injuries. Police subsequently dragged, beat and subjected her to racially-charged insults. She was detained for two and a half hours before being read her rights. Four hours after her arrest, she received medical treatment for burns on her stomach, pulmonary spasms and massive body blows sustained during her arrest. She was "provisionally" released in the evening but now faces charges of sedition and blocking the public rights of way. The sedition charge carries the possibility of 10 to 15 years in prison.

On March 30 the public school teachers and the FNRP called a national strike in response to the ongoing repression and the detention of 18 teachers on March 25, who are considered political prisoners because they are being charged with sedition and illicit protest.

In light of these facts, we strongly urge that you

- immediately institute effective measures to ensure that human rights defenders can carry out their legitimate and peaceful activities free of all restrictions and without fear of reprisals, including judicial harassment;
- conduct an immediate, thorough and impartial investigation into the death of Ivania Velásquez Rodriguez as
 well as the injuries and charges against Miriam Miranda Chamorro and bring those responsible to justice in
 accordance with international standards.
