Dear Sirs:

We are concerned for the safety of the following persons in Barrancabermeja, Santander Department, who have received death threats: **LGBT activist Ovidio Nieto Jaraba** of People in Action; **William Mendoza**, President of the Barrancabermeja branch of the Colombian Union of Food Industry Workers (SINALTRAINAL); **Himad Abdala Choser**, a local human rights defender; and members of the Regional Human Rights Corporation (CREDHOS), the Association of Victims of State Crimes in Magdalena Medio Region (ASORVIMM), the Peasant Farmer Association of the Cimitarra River Valley (ACVC) and the Association of Displaced People Settled in the Municipality of Barrancabermeja (ASODESAMUBA).

On July 27 the local LGBT community organized its first march in the municipality of Barrancabermeja for the respect and recognition of the LGBT community. Organizers and their supporters have since been threatened. Oviedo Nieto Jaraba received several threatening phone messages. On August 14 an envelope with a bullet cartridge and a flyer with a death threat was found in Himad Abdala Choser's home. The flyer also threatened CREDHOS, ASORVIMM, People in Action, SINALTRAINAL, ACVC and ASODESMUBA.

On August 18, the paramilitary group "Rastrojos Comandos Urbanos" left a leaflet at the office of People in Action containing death threats against the individuals and local organizations named above. It accused them of "provoking and organizing protest marches" and supporting guerrillas and stated that "there will be no more threats but actions...we are regaining the control of all entities."

Because of these threatening actions, we strongly urge that you

- ensure the authorities protect all individuals and organizations mentioned above, in line with their wishes;
- conduct full and impartial investigations into the death threats, publish the results and bring those responsible to justice;
- fulfill your obligations regarding the protections of human rights defenders as specified in the 1998 UN Declaration on Human Rights Defenders, to which Colombia is a state party; and
- immediately dismantle paramilitary groups and break their inks with the security forces, in line with stated government commitments and recommendations made by the UN and other intergovernmental organizations.
