Dear Sirs:

We are deeply concerned about threats to **Igor Diaz López**, president of the National Trade Union of Coal Industry Workers (SINTRACARBON) and **Aldo Raúl Amaya Daza**, treasurer of SINTRACARBON in La Guajira Department. On January 6, 7, and 8 a man who telephoned Amaya Daza's home in San Juan del Cesar said, "Tell Amaya to be careful, because he is in our sights." An armed man whom the family saw outside their home left the area when the family came out, and neighbors alerted the police. On January 10 Igor Diaz López's wife received a call to her mobile phone warning her that she and her family were being followed.

Both men have been members of the committee negotiating a labor agreement with a coal company on behalf of the mine workers. On January 19 a first phase of the negotiation ended and workers were deciding whether to go on strike.

Members of SINTRACARBON have received death threats while the union has been seeking improved working conditions. On July 18, 2012 Igor Diaz Lopez was told, while he was in a meeting of the union's negotiating committee, that he and his family should leave the country.

Colombia has one of the highest rates of killings of trade unionists who face repeated death threats or are killed during labor disputes and their campaign for improved pay and working conditions. They have been repeatedly threatened and many have been extrajudicially executed or subjected to enforced disappearance by paramilitaries, acting either alone or in collusion with the security forces.

Based on these facts we strongly urge that you

- provide protection for those threatened, as agreed to by those in danger;
- launch a full and impartial investigation into the threats against Igor Diaz López and Aldo Raúl Amaya Daza, publish the results and bring those responsible to justice.
