## Dear Sirs:

We are deeply concerned about the recent death threats sent by paramilitaries to a human rights lawyer, trade union leaders, and environmental defense activists. On April 29 a written death threat declaring the following individuals "military targets" was sent to the offices of the Colombian Trade Union Congress (CUT) in Bucaramanga, the capital of Santander Department: **Leonardo Jaimes**, a human rights lawyer with the Committee of Solidarity with Political Prisoners (CSPP), trade unionists **Martha Díaz** (of ASTDEMP, Association of Public Servants of Santander) and **David Flórez** (of CUT–Santander branch) and environmental campaigners **Diego Riaño** and **Jimmy Moreno**. The threat, signed by the paramilitary group Self-Defense Forces of Colombia–Los Rastrojos–Los Urabeños Command, accuses the human rights workers of organizing peasant farmer demonstrations, which they allege are supported by guerrilla groups.

Some of these people and their family members have been threatened before. In December 2010, while Martha Díaz was president of ASTDEMP, her 17-year-old daughter was taken at gunpoint off the street in Bucaramanga, forced into a taxi cab and pushed to the floor, slapped in the face, and told by her adbuctor: "if your mother continues with her guerrilla activities, the consequences will be much worse." She was pushed out of the car onto a highway about an hour later. Fortunately, she survived.

Human rights defenders and others who have challenged the impunity of members of the security forces and paramilitaries in Colombia have repeatedly been labeled as subversives by these forces. Such accusations have often been accompanied or followed by death threats and other serious human rights violations.

Because of our concern for the safety of persons named above we strongly urge that you

- > order full and impartial investigations into these threats and the presence of paramilitaries, make the results public and bring those responsible to justice;
- > implement protection measures, in strict accordance with the needs and wishes of those threatened;
- take immediate action to dismantle paramilitary groups and break their links with the security forces, in line with stated government commitments and recommendations made by the UN and other intergovernmental organizations.
