Dear Sirs:

We are outraged at the murder, on November 4, of Edilberto Niño Cristancho, a senior leader of the National Union of Workers in the Cooking Fats and Food Industry (SINTRAIMAGRA), in Villavicencio in Meta Department.

Two men attacked Niño Cristancho as he got into a taxi in Villalvicencio. He died of multiple stab wounds. Edilberto Niño Cristancho was working with the Central Workers Union (CUT) to ensure that palm companies fully comply with workers' constitutional and legal rights and with International Labor Organization (ILO) conventions concerning the right of workers to form unions and bargain contracts.

Palm oil workers in Colombia are part of a global supply chain for household products and cosmetics. They are forced to work long hours in hazardous conditions without adequate safety equipment or protection from contact with acutely toxic chemicals such as paraquat.

According to the National Trade Union School, 14 union members were murdered, six were physically attacked and 134 threatened with violence between January 1 and the end of August of this year. Perpetrators are rarely punished.

We are quite concerned about the dangerous situation faced by labor leaders in Colombia. We **strongly urge** that you

- conduct an immediate and complete investigation into the death of Edilberto Niño Cristancho, publish the results, and bring those responsible to justice;
- provide security guarantees to union members and union leaders, in strict accordance with their wishes
