Dear President Duque and Attorney General Barbosa:

We are concerned about threats to social leader **Leider Valencia Tumbo** in Miranda municipality, Cauca Department. On January 2 at 7:30p.m., two men got off a motorcycle, forcibly stopped a young man, pointed a gun at him, and asked him "if he was Leider." When he responded "no," the man with the gun asked the second man from the motorcycle, "Is it him?" When the second man responded "no," they let the young man go.

Leider Valencia Tumbo is a well-known social leader in Southwestern Colombia. He serves as a municipal delegate for various social organizations, including: FENSUAGRO-CUT (National Federation of Agricultural Trade Unions-Central Union of Workers), PUPSOC (Process for Popular Unity of Southwestern Colombia), the Patriotic March, and notably COCCAM (National Organization of Cultivators of Coca, Poppy, and Marijuana). COCCAM functions as the Territorial Advisory Council for the implementation of the national Program for the Voluntary Substitution of Illicit Crops (PNIS).

PNIS is popular with farming families, providing them a way to transition from growing coca to other income-generating crops. But they experience heavy pressure from organized criminal groups to continue growing coca for the lucrative cocaine trade. Pressure sometimes translates into assassination: More than 50 members of COCCAM have been killed since the Peace Accords were signed in 2016 (cf our letters of July 1 and July 26, 2019; Jan 26, May 25 and June 22, 2020). Human rights abuses are also being committed by military personnel who are deployed to rural areas to forcibly eradicate coca.

Spending millions of dollars on the militarization of the "War on Drugs" is actually undermining PNIS. Heavily militarized drug eradication efforts—together with the general presence of military forces in rural farming areas—creates a hostile environment for social leaders such as **Leider Valencia Tumbo** who live under constant threat by armed groups. Because we believe that he is in serious danger, we **strongly urge** that you

- carry out a transparent and thorough investigation into ongoing acts of surveillance, intimidation, and any death threats against Leider Valencia Tumbo, publish the results, and bring the perpetrators to justice
- take immediate steps to guarantee the physical safety and psychological integrity of Leider Valencia Tumbo, in strict accordance with his wishes
