Dear Sirs:

We are writing for accountability and protections regarding continued threats against and armed attacks on the Nasa Indigenous reserve Las Delicias near Buenos Aires, Cauca Department. Two armed attacks last month resulted in the deaths of three indigenous guard members, one of whom was only 14 years old.

Breiner David Cucuñame López, a 14-year-old environmental defender and member of the Student Indigenous Guard of Cauca, was shot and killed on January 14 during an attack by an armed group in the Indigenous reservation (*resguardo*) of Las Delicias. He and his father were on their way to a construction job. Another member of the indigenous guard, **Guillermo Chicame Ipia**, was also killed during this attack, and at least four other indigenous people were injured.

In a separate attack at the Las Delicias reservation on January 24, **José Albeiro Camayo Güetio**, a former coordinator of the Guardia Indígena del Cauca, was killed. During the attack, the armed group also kidnapped his teenage son Arlin Camayo and nephew Breiner Camayo, who were later released.

The Guardia Indígena del Cauca is a community protection network made up of women, men, boys and girls, part of ACIN (Association of Indigenous Councils of Northern Cauca), who peacefully defend their territories. Most of the guard members are Nasa peoples trying to protect their autonomy and ancestral lands from those who seek territorial control. Since 2001, the Guardia Indigena del Cauca has trained other communities to peacefully defend their own territories

We are deeply concerned about the dangers facing Nasa Indigenous peoples in Cauca who are under pressure from illegal armed groups that are promoting the expansion of illicit crops, illegal mining, and drug trafficking. Those who speak out against their efforts are subjected to violence and death. On April 20 2021, four armed men abducted Indigenous Governor Sandra Liliana Peña Chocué from her home at the La Laguna-Siberia reserve in Caldono. They shot and killed her (cf our letter 28 April 2021). Just prior to her murder, she had spoken out against the increase in illicit crop cultivation in the reserve.

We strongly urge that you

- conduct a thorough and transparent investigation into the killings of Breiner David Cucuñame López, Guillermo Chicame Ipia, and José Albeiro Camayo Güetio publish the results, and bring those responsible to justice
- meet with representatives of the Regional Indigenous Council of Cauca (CRIC) to devise a protection mechanism scheme for the families of Las Delicias, in strict accordance with their wishes
