Dear Sirs:

We are deeply distressed over recent attacks on the staff of CREDHOS (Regional Corporation for the Defense of Human Rights), an organization committed to the defense, promotion, and protection of human rights in the Magdalena Medio region of Colombia since 1987. In recent months there has been an increase in threats and harassment to social organizations and human rights defenders in the Magdalena Medio region and in Barrancabermeja, Santander Department, in particular.

On April 10, a bomb was placed outside the CREDHOS office in Barrancabermeja. Police suspected it was placed there by members of the National Liberation Army (ELN). One day later, armed civilians shot at CREDHOS staff were while they were accompanying an administrative police procedure in the area known as "Finca El Hebron" in Barrancabermeja. Also present were two members of International Action for Peace (IAP) from Spain, who were providing international accompaniment to the CREDHOS staff. The IAP members were clearly identified as international peace accompaniers with vests indicating their peaceful role. It is our understanding that the National Police captured two of the assailants, charged them, and released them on April 13.

We are deeply concerned for the safety of CREDHOS staff, who have been victims of threats and attacks for many years. A few years ago, the AGC paramilitary organization AGC (Gaitanista Self-Defense Forces) circulated a pamphlet in Barrancabermeja with a list of targets they accused of colluding with the government and left-wing armed rebels. The list included at least two leaders of CREDHOS. AGC stated that they would bring them back "chopped up in plastic bags."

We urge the Colombian authorities to:

- carry out a thorough and transparent investigation into the attacks on CREDHOS staff, publish the results, and bring those responsible to justice, in accordance with international standards
- include in the investigations any patterns of victimization towards human rights defenders committed by irregularly armed civilians presumably organized in "citizen security fronts"
- provide CREDHOS and its staff with effective individual and collective protection measures, in strict accordance with their wishes
- prevent further violence by guaranteeing that all human rights defenders and all international peace observers, including CREDHOS and IAP, are able to carry out their legitimate human rights activities without fear of restrictions or reprisals in Colombia.
