Trends in 2019

COLOMBIA

targets: indigenous and Afro-descendant leaders, journalists, national strike participants, labor organizers, LGBTI rights defenders, women's rights defenders, former FARC members active in reintegration into civilian society (as designated by the 2016 Peace Accords), farmers active in the national crop substitution program (switching over from growing coca to growing legal crops), and environmental and land rights defenders

EL SALVADOR

targets: journalists, LGBTI rights defenders, women's and reproductive rights leaders

GUATEMALA

targets: indigenous communities (their allies, their lawyers) defending land, environmental, and cultural rights in opposition to hydroelectric, mining, and other mega-development projects

HONDURAS

targets: journalists, protesters in the street and those monitoring protests, indigenous communities (plus their allies, their lawyers) organizing resistance to mega-development projects, labor movement and union leaders

MEXICO (in the southern, mostly indigenous states)

targets: community leaders, indigenous and environmental defenders

NICARAGUA

targets: news outlets, anti-government demonstrators (criminalization of student leaders, other activists)

COLOMBIA

- Jan 11 attempted assassination of indigenous leader **Alejandro Pascal Pai** and his wife; he was recently elected Awá governor of the Pingullo Sardinero community in Barbacoas municipality, Nariño Department.
- Jan 12 assassination of **Gilberto Valencia**, social entrepreneur, peace builder and cultural manager of Suárez municipality in Cauca Department. He was shot and killed for his work disseminating the terms of the 2016 Peace Agreement between the government and the former Revolutionary Armed Forces (FARC).
- Jan 12 assassination of **Jesús Adier Perafán**, founder of Courage Caicedonia and president of the Community Action Board of his neighborhood, by two armed men in Caicedonia municipality, Valle del Cauca Department.

- Jan 12 assassination by four armed individuals of **Wilmer Antonio Miranda**, an active member of the Association of Rural Workers of Cajibio in Cauca Department and a supporter of the crop substitution program that enables transitioning to legal crops replacing marijuana, poppy, and coca.
- Jan 12 assassination by four strangers of **José Rafael Solano**, president of the Community Action Board and manager of social projects for peasant farmers, including the defense of ancestral mining practices.
- Jan 12 assassination of **Wilson Pérez Ascanio** by 5 unidentified armed men on motorcycles in the Catatumbo region of Hacarí in Norte de Santander Department. He was the leader of several social movements, including the Popular Constituent Movement (MCP).
- Jan 12 assassination of **Maritza Quiroz**, mother of four and an Afro-Colombian representative on the Santa Marta Victims' Roundtable who worked on reparations for the victims of torture, kidnapping, displacement, and sexual violence that have occurred during Colombia's 50 year armed conflict.
- Jan 24 armed attack on human rights defender **Alfamir Castillo Bermúdez** near Pradera Municipality in Valle del Cauca Department for her work pursuing truth and justice for extrajudicial killings carried out during the armed conflict.
- Jan 26 intimidation and assassination of community Action Board member **Miguel Antonio Gutiérrez** at his home in Cartagena del Chairá, Caquetá Department.
- Jan 26 abduction and assassination of **Faber Manquillo Gómez**, a rural organizer missing since December 26. He went missing in late December and was found dead in El Rosario near the Cauca border, Nariño Department.
- Jan 26 assassination of **Maritza Ramírez Chaverra** by unknown men in the El Tigre zone of Nariño. She was President of the Community Action Council in the village of Aguas Claras and helped coordinate programs to substitute traditional crops for illegal coca crops.
- Jan 26 abduction, torture, and assassination of **Luis Alfredo Contreras Ortega**, President of the Community Action Board in Las Mercedes and coordinator of voluntary replacement of coca plantations with legal crops in the Sardinata zone, Norte de Santander Department.
- Jan 26 assassination of **Lede María Ortega Ortiz**, who worked as a worked as secretary for the Community Action Board of El Tarra, of which she was also a member, in the village of Mundo Nuevo, near El Tarra municipality, Norte de Santander Department.
- Jan 26 assassination of **José Jair Orozco Calvo**, member of the Community Housing Board of the Vista Hermosa Urbanization, a housing project for low-income residents, Valle de Cauca Department.
- Feb 1 assassination of labor organizer **Dilio Corpus Guetio**, a member of the **Mountain Area Association of Campesino Workers** (**FENSUAGRO** affiliate) coordinating peasant farming communities and a member of the local volunteer Campesino Guard, which oversees security and organizing for rural communities. Cauca Department.
- Feb 25 intimidation, abduction, and torture of Dibeth Quintana, a leader of the Oil Workers' Union (USO) in Aguachica Municipality, Cesar Department.
- Feb 26 assassination of **José Fernel Manrique Valencia**, age 34, an executive board member of the Union of Construction Material Industry Workers (SUTIMAC).
- Mar 21 abduction and assassination of rural organizers **Milena García** and her husband, **Darwin Reyes**. The couple were community leaders in the rural reserve Zona de Reserva Campesina Perla Amazónica (ZRCPA), where they helped coordinate voluntary crop substitution programs in Puerto Asís, Putumayo Department.
- Mar 21 assassination of **Doctor Zonia Rosero**, a community healthcare provider and advocate for women's rights and peace who coordinated a regional campaign against gender-based violence and was planning to announce her candidacy for mayor of Puerto Asís promoting education and health as fundamental rights for all communities.

- Mar 22 assassination of LGBTI rights defender **Liliana Holguín** and **her nephew** (unnamed), for her work with the LGBTI Committee of Caucasia, which campaigns against discrimination and in defense of equal rights, and for her leadership of support for victims of forced displacement in her Bajo Cauca region of Antioquia department.
- Mar 25 displacement, abduction, torture, and assassination by paramilitary forces of **Jhon Jeimer González Vasquez** and **Julio César Taborda Caro**, as well as the abduction of one more rural worker, and the forced displacement of hundreds of families in the areas from which the Revolutionary Armed Forces of Colombia (FARC) withdrew following the signing of the peace agreement in 2016.
- Mar 26 assassination of a rural organizer **Argemiro López Pertuz** for his support of the Comprehensive National Program for the Substitution of Illicit Crops (**PNIS**) and his work implementing PNIS (substitute the growing of coca with legal crops) in the village of La Guayacana in Tumaco municipality, Nariño Department
- Apr 11 assassination of **Edwin Andrés Grisales Galvis**, a musician and a member of a regional collective of popular artists (RAPSO) which uses music and the popularity of musicians in pop culture to promote the proliferation of peace and social justice.
- Apr 11 assassination of **Ebel Yonda Ramos**, an indigenous leader for the Nasa people who used his authority as a former governor to La Gaitana community to promote the rights of indigenous populations, especially in regards to land rights.
- Apr 23 assassination of **Policarpo Guzmán Mage**, a rural and agricultural labor organizer and human rights defender in Cauca Department through his participation in and leadership of numerous peasant, campesino, and human rights organizations and unions.
- Apr 24 assassination of **Nixon Willington Valencia**, a rural and agricultural labor organizer and human rights defender in Putumayo Department who has participated in and lead actions with FENSUAGRO and the Patriotic March social movement.
- Apr 26 assassination of **Samuel David Gonzales Pashaina**, a seven month old baby of a former FARC combatant who was undergoing the transition to civilian life. The family of three was attacked but Samuel David was the lone casualty.
- Apr 26 the assassination of **Dimar Torres**, a disabled former FARC combatant, who was going through the civilian transition process outlined by the 2016 peace accords.
- May 11 the circulation of defamatory and threatening pamphlets about Fuerza de Mujeres Wayuu, including threats to the lives of its director, Jakeline Romero, and five of its members: Karmen Ramírez, Miguel Ramirez, Deris Paz, Luis Misael Socarras and Dulcy Cotes.
- May 24 the assassination of **Daniel Eduardo Rojas Zambrano**, the President of the Community Council in the indigenous reserve of López Adentro in Cauca Department.
- May 24 the assassination of indigenous leader **Miguel Ángel Alpala**, member of the Indigenous Authorities of Colombia (AICO), who helped coordinate indigenous and rural protests, known as "La Minga."
- May 25 the murder of **Dr. Christian Camilo Julio Arteaga**, age 24, in El Bagre in the Bajo Cauca region of Antioquia Department, who was in the region serving the community during his rural placement year required for medical certification.
- May 26 **Giovanny Murillas**, once a FARC combatant, was killed in Guaviare Department wherein the AGC paramilitary group had recently distributed pamphlets labeling FARC members as "military objectives," announcing a plan to "exterminate" them.
- May 26 former FARC commander **Jorge Enrique Corredor** was assassinated, marking the highest-ranking member of the FARC murdered since the peace agreement was signed in 2016. Jorge Corredor had played a key role in establishing contact between the government and the FARC during the conflict.
- Jun 21 assassinations of two leaders in Nariño: **Benedicto Valentia**, President of the Community Council of Miraflores, was assassinated for his protection of land rights and his participation in programs of land restitution aiming to

- benefit people forcibly displaced from their homes by violence; **Paula Andrea Rosero Ordóñez**, lawyer and representative of the Public Ministry of Samaniego, was assassinated for her career defending human rights and targeting corruption in Samaniego
- Jun 22 assassinations of three Awa indigenous following death threats given during the Awa annual general assembly: Leidy Jacqueline Burgos Pai, age 18, student at the Awa Bilingual Agro-Environmental Technical Education Institution and member of the indigenous reservation Resguardo Honda Rio in Barbacoas municipality, Nariño Department; Rocío García Pai, mother of two and member of the Awa reservation Hojal la Turbia de Tumaco, Nariño Department; Robert Dionisio García Bisbicús, age 21, of the Awa Indigenous Reservation of Gran Rosario in the municipality of Tumaco, Nariño Department.
- Jun 24 the public assassinations by the armed group Virgilio Peralta Arenas ("Caparros") of two farmers active in the PNIS crop substitution program San José de Uré, Córdoba Department: **Jader Pertuz** and **Jader Polo** were members of the Peasant Farmer Association of Southern Córdoba
- Jun 24 the fatal beating by police, military, and heavily armed ESMAD (Mobile Anti-Disturbance Squadron) units, of 16-year-old indigenous human rights defender and FENSUAGRO trade unionist **Jeferson Tróchez Escue** at a farm in Caloto in Cauca Department.
- Jun 25 the assassination of **María del Pilar Hurtado**, an activist and a leader in social and environmental rights defense in her community. Her 12-year old son witnessed the assassination in Tierralta, Córdoba Department.
- Jul 1 assassinations of two former FARC members in Cauca, two in Nariño, one in Córdoba. In Cauca: Rafael Polindara, Anderson Pérez Osorio (also a member of FENSUAGRO trade union). In Nariño: Daniel Esterilla, Servio Delio . In Córdoba: Manuel Gregorio González Segura (also active in the campesino association ASCSUCOR)
- Jul 2 death threats by AUC paramilitaries to **Yirley Velasco**—as well as her family—for her work defending and empowering women and her participation on the El Salado Victims Roundtable, condemning the actions of the AUC during the El Salado massacre of 2000. Carmen de Bolívar, Bolívar Department.
- Aug 2 the intimidation of social leaders leaders Yampier Valencia, Orlando Castillo and Norha Isabel Castillo, all active with CONPAZ (Comunidades Construyendo Paz en los Territorios) by paramilitary members in Buenaventura, Valle del Cauca Department.
- Aug 2 the intimidation by armed paramilitary members of **Luis Yasmani Grueso**, an Afro-descendant civic leader and comanager of the Puente Nayero Humanitarian Space in Buenaventura, Valle del Cauca Department.
- Aug 2 death and displacement result from fighting paramilitary groups Urabeños and Bustamante in Buenaventura, Valle del Cauca Department: killing of **David Vivas Ramírez**, age 20, caught in crossfire; displacement of 74 families in Comuna 3 district; displacement of 200+ families in the Lleras neighborhood
- Aug 2 an **unnamed Afro-descendent woman** was seen being forced from her boat by heavily armed and hooded men on the Lower Calima River. Her lifeless body was discovered on the river banks the next day by fellow residents of the Santa Rosa de Guayacán Humanitarian and Biodiverse Reserve.
- Aug 2 an assassination attempt on **Carlos A. Tobar**, an Afro-descendant civic leader and coordinator of Access to Justice Table, left him hospitalized in critical condition in Buenaventura, Valle del Cauca Department.
- Aug 16 surveillance of and suspected intent to assassinate **Danelly Estupiñan**, an Afro-descendent peoples' rights activist with Black Community Process (PCN) in Buenaventura, Valle del Cauca Department.
- Sep 1 surveillance, slander, and attack against **Isabel Zuleta**, **Milena María Flórez**, y **William de Jesus Gutierrez**, environmental activists and human rights defenders in their community around the Cauca River.
- Sep 24 death threats to **FECODE**, the (Federation of Education Workers), the largest trade union in Colombia, and its leadership including **Nelson Alarcón**, **Martha Alfonso**, **Domingo Ayala**, and **Carlos Rivas**, Bogotá.
- Sep 25 assassination of three more ex FARC combatants, **Milton Urrutia Mora**, **José Milton Peña Pineda**, and **Jackson Mena**, Norte de Santander and Chocó departments.

- Aug 2 forced displacement of 200 families by paramilitary groups. Some residents are being caught in the crossfire; some have died, Buenaventura, Valle del Cauca Department.
- Aug 26 unauthorized and nonconsensual surveillance of **Danelly Estupiñan**, a leader of the **Black Community Process** (**PCN**). This letter also concerns the report that there was a transaction made exchanging money for the assassination of Danelly, Buenaventura, Valle del Cauca Department.
- Sep 1 unauthorized and nonconsensual surveillance, slander, and attacks against **Isabel Zuleta**, **Milena María Flórez**, and **William de Jesus Gutierrez**, environmental activists and human rights defenders resisting the development of a hydroelectric project, **Hidroituango**, in their community around the Cauca River.
- Sep 24 death threats to **FECODE** and its leadership -including **Nelson Alarcón**, **Martha Alfonso**, **Domingo Ayala**, and **Carlos Rivas** in a pamphlet circulated by the Black Eagles (Águilas Negras) paramilitary group.
- Sep 25 assassination of three more ex **FARC** combatants, **Milton Urrutia Mora** (Cúcuta), **José Milton Peña Pineda** (Cúcuta), and **Jackson Mena** (Quibdó). Additionally **Arsenio Maldonado** was badly injured in the same attack that killed Milton and José, Cúcuta, eastern Colombia, Quibdó, Chocó region.
- Oct 24 assassinations of four indigenous social leaders: **Toribio Canas Velasco** (Cauca Dept), **Lilia Patricia** García (Nariño Dept), **Oneida Epiayú** (La Guajira Dept), **Constantino Ramírez Bedoya** (Quindío Dept).
- Nov 13 violent attacks on several indigenous people in less than a week in the **Nasa Tacueyo** reservation in Corinto, Cauca Department. Twelve were murdered, an assassination attempt on another, and others injured.
- Nov 15 burning of the boat and outboard motor belonging to journalist **David Torres** in Simití in Bolivar Department in an attempt to silence his critical reporting.
- Nov 26 killing of student demonstrator **Dilan Cruz** who was hit by tear gas canister thrown by riot police on November 23. He died from head injuries two days later, Bogotá.
- Dec 22 assassinations of three people during this time of national strike: a former FARC member, **Manuel Santos Yatacue**, the mayor of Sutatausa, **José Humberto Rodríguez**, and a community leader from Cases Grandes which was a FARC stronghold during the conflict, **Elicerio Mendoza**.
- Dec 23 nonconsensual surveillance against members of **dhColombia**, a human rights defense organization. Surviellance includes stalking, information and communication theft, and death threats made towards these community leaders.
- Dec 25 threats made by the National Liberation Army (ELN) and Gaitanistas Self-Defense Forces of Colombia (AGC) towards the indigenous and afro-descendant communities in the municipality of Bojayá.

EL SALVADOR

- Feb 22 deportation and assassination of **Camila Díaz Córdova**, a transgender woman who sought political asylum in the US but was deported to her native El Salvador
- Mar 23 defamatory attacks against LGBTI rights leaders **Andrea Ayala** and **Barbara Romero** of ESMULES (Salvadoran Lesbian Women's Space for Diversity) in San Salvador.
- Aug 1 smear campaigns, threats, and online harassment against journalists **Bessy Ríos**, **Karen Fernández** and **Mariana Belioso**, for their criticism of the government's new "plan de control territorial" which will increase police and military presence in certain regions.
- Oct 23 re-criminalization of **Evelyn Hernández** after judge declared her innocent in August. This was following her twoyear detention for a complication in her pregnancy, which resulted in a stillbirth, originally deemed an infanticide by the court.
- Dec 24 slander charges and an exorbitant fine on **Lissania Zelaya** of **Amorales Collective**, both of whom are being persecuted for "slander" in their condemnation of acts sexual harassment and assault by University of El Salvador faculty member, Ricardo Mendoza.

GUATEMALA

- May 23 death threats toward, nonconsensual surveillance of, and attempted attack on **Quelvin Jiménez**, lawyer of the indigenous **Xinca** people in San Rafael las Flores in Santa Rosa Department.
- Jul 3 attacks against the **Nuevo Día Ch'orti Indigenous Association (CCCND)** for their work defending land, environmental, and cultural rights in opposition to hydroelectric and mining projects in their territories in Olopa municipality in Chiquimula Department.
- Jul 3 attack on indigenous leader **Irma Méndez** by the owner of the Cantera los Manantiales mine in an attempt to break up a half-a-year-long **Cho'orti** peaceful protest in Olopa municipality in Chiquimula Department.
- Aug 3 surveillance of and attacks made against **Quelvin Jiménez**, lawyer for the **Xinca** people in San Rafael las Flores, Santa Rosa Department.
- Dec 26 intent by Escobal mine to ignore a 2018 court ruling forbidding the creation of the mine without consultation with the Xinka community, the ancestral keepers of the land on which the mine sits.

HONDURAS

- Mar 24 assassination of journalist **Leonardo Gabriel Hernández**, the director and presenter of the program *El Pueblo Habla* (The People Speak), broadcast on *Valle TV* Channel 25, on which he discussed social issues and local politics and was known to speak out critically against the municipal government
- Apr 12 attack by the Honduran National Police on individuals associated with **Hedme Castro** and **ACI PARTICIPA**, which promotes citizen participation in decision-making and the exercise of civil and political rights, as well as administration transparency.
- May 22 threats and attacks against **Rosalina Domínguez**, Finance Coordinator for the Indigenous Council of Río Blanco in Intibucá Department, her four sons (ages 16 to 30), and two other members of the Civic Council of Popular and Indigenous Organizations of Honduras (COPINH).
- Jun 26 military forces shot and killed **Erick Peralta**, a 37-year-old taxi driver, as he stepped out of his vehicle to get through protests calling for the removal of President Juan Orlando Hernández in Yarumela, La Paz Department.
- Jun 26 military forces shot and killed 24-year-old **Luis Maldonado**, a peaceful protestor in the demonstrations against the government's efforts to privatize education and health care in Yarumela, La Paz Department.
- Jun 26 **Eblin Noel Corea Maradiaga,** age 17, was shot and killed while maintaining a road block during peaceful protests in Yarumela, La Paz Department.
- Jul 14 political prisoners **Edwin Espinal, Raul Alvarez**, and **Romel Portillo** are human rights defenders who have been wrongfully detained since 2018 in the maximum security, military run "La Tolva" military prison, in which they are receiving death threats and being isolated and denied medical treatment.
- Jul 16 the Madrid family destroyed with machetes more than 15 manzanas of the Lenca indigenous community's corn harvest, destroying the principal food source and main livelihood of at least 25 families. The incident took place on the land that was intended for the Agua Zarca hydroelectric project. Río Blanco community, Intibucá Department.
- Aug 14 death threats to **COPINH** Finance Coordinator **Rosalina Domínguez**, her family, and other members of the indigenous Lenca community at Río Blanco in Intíbuca Department.
- Sep 22 assassination of **Edgar Joel Aguilar**, an outspoken and critical television reporter who would often report on both regional and national crime and corruption, Nueva Arcadia Municipality, Copán Department.
- Sep 23 death threats, intimidation, and attempted extortion of TV reporter **Miguel Ángel Tróchez**. Targeted for his controversial and pointed reporting style in response to crime in the Santa Barbara Department.

- Sep 26 the unjustified arrest of and attack against **Elizabeth Medina** and **Katherin Cruz Cerrato** who were monitoring peaceful protest on behalf of their human rights defense organizations in Francisco Morazán Department.
- Oct 1 criminalization of **María Concepción Hernández**, member of the Board of Directors of **ADEPZA** (the Association for the Development of the Zacate Grande Peninsula) and land and environmental rights defender, protecting the land and beaches of Zacate Grande, Valle Department.
- Oct 22 attempted assassination of **Sandra Maribel Sánchez**, anchor and journalist for **Radio Progreso**, targeted because of her critical reporting on government affairs.
- Oct 25 criminalization of social protest and detention ofthose defending human lives, property, freedom, and the physical environment. This includes 15 political prisoners who continue to be held for trumped up charges.
- Oct 26 assassination of five women leaders and members of **Garífuna** communities (and two men) since early September: **Mirna Teresa Suazo Martínez** (Masca beach, Cortés Department), **Gilma Antonia Cacho** and her five-year-old daughter, **Fiori Amaya Cacho** (Santa Rosa de Aguan, Colón Department), **Nayda Reyes Jiménez** and her **husband** (Puerto Cortés, Cortés Department), **María Digna Montero** (Iriona, Colón Department), **Óscar Francisco Guerrero Centeno** (Triunfo de la Cruz, Atlántida Department).
- Nov 12 attempted assassination of union leader **Jaime Atilio Rodríguez**, a former president of the College of Teachers of Middle Education of Honduras (COPEMH).
- Nov 14 assassination of journalist **Buenaventura Calderón**, killed by armed gunmen in front of his house on November 1. His wife was also killed in the attack in Puerto Lempira.

MEXICO

- Jan 25 assassination of human rights defender **Sinar Corzo Esquinca** in Arriaga, Chiapas, for his work with the Citizen Committee for the Defense of Human Rights, and his defense of the right to water, health, security and basic services for citizens of diverse communities.
- Feb 23 assassination of **Noé Jiménez Pablo** and **José Santiago Gómez Álvarez**, members of the Independent Regional Campesino Movement (MOCRI) in Amatán, Chiapas
- Feb 24 illegal detention, fabrication of charges, and abuse to **Froylán González**, a member of the Committee for the Defense of Indigenous Peoples (CODEDI), which works to defend and transform living conditions in 48 indigenous communities in Oaxaca State.
- Apr 25 assassination of **Luis Armando Fuentes Aquino**, an indigenous and environmental defender on the Isthmus of Tehuantepec in Oaxaca State. He was targeted for his opposition to development policies and projects that conflict with indigenous peoples' right to self-determination.
- Jul 15 assassination of **Mario Moreno Jiménez**, member of National Front for Socialism (FNLS); he worked defending land rights for campesinos and publicly denouncing human rights violations perpetrated by the Mexican government. Venustiano Carranza, Chiapas.
- Aug 15 harassment and intimidation by Mexican authorities of personnel working at the **Casa del Migrante de Saltillo** in Coahuila.
- Nov 11 disappearance of **Arnulfo Cerón Soriano**, a Nahua indigenous lawyer of the La Montaña region in Guerrero.
- Dec 1 assassination of **Arnulfo Cerón Soriano**, a Nahua indigenous lawyer of the La Montaña region in Guerrero.

NICARAGUA

- Jan 13 police censorship, raiding, and banning of independent television news channel **100% Noticias** in Managua and the arrest of two of its journalists: **Miguel Mora Barberena**, the station's owner and director, and **Lucía Pineda Ubau**, the station's news director.
- Jun 23 more than **80 political prisoners** remain behind bars (according to opposition groups), despite calls by OAS to release activists, demonstrators, student leaders, journalists and others who have been criminalized for protest over the past year
